

“New Car and Truck Dealers American Dream” Scholarship Program

2018 Scholarship Program

The term “American Dream” first appeared in a book written by James Truslow Adam where he stated the American Dream is ‘that dream of a land in which life should be better and richer and fuller for everyone, with opportunity for each according to ability or achievement.’”

From Henry Ford and Lee Iacocca to the new car and truck dealers in your local community, many in the auto industry have strived for the American Dream.

Washington State’s franchised new car and truck dealers serve 75 communities around the state and together provide over 20,000 people with good, family-wage jobs. Auto dealers reinvest and contribute millions to Washington communities through taxes and contributions to charitable organizations.

The state’s new car and truck dealers have worked hard to establish and grow their businesses and in turn, give back to their communities in hopes of making it a better place and helping others achieve their own American Dream.

Tell us in an essay . . .

What is YOUR American Dream and how do you plan to fulfill it?

You may be handsomely rewarded . . .

- Two \$2,500 scholarships will be awarded – one each for an eastern Washington student and a western Washington student (no dealership affiliation required.)
- One \$2,500 scholarship will be awarded to an employee of a WSADA-member dealership, or an immediate family member of a WSADA-member dealership employee.
- Two \$2,500 scholarships will be awarded to a Washington student enrolling, or currently enrolled, in an Automotive Technology program in Washington.

Here are the details . . .

Eligibility: Only high school seniors enrolled in a Washington State public or private high school, as well as those who are home-schooled and reside in Washington State, are eligible to enter. For the Automotive Technology program scholarships, only students currently enrolled in or applying to a Washington State public school Automotive Technology program (full list available at www.wsada.org) are eligible to enter.

The **Student Information/Release Form** must be included which provides student and school information, parent permission (for applicants under the age of 18) and statement of originality from student. Immediate family members of WSADA Dealer Member owners/principals are not eligible.

JUDGING CRITERIA:

Essay = 60 points

- Two page, double-spaced essay (approximately 500 – 700 words)
- First and last name should appear on the top right side of each page

TWO Letters of Recommendation Reflecting Scholarship Worthiness AND Service to Others* = 30 points

**Service to others can include contributions to school, community, or family:*

- One letter of recommendation (on letterhead) must be from a teacher or school advisor;
- One letter of recommendation (on letterhead) must be from an employer or a representative of a service or charitable organization.

Resumé = 10 points

- One page outline of high school achievements, activities, awards, work and/or volunteer experience. Applicants for the Automotive Technology program scholarships, who are not current or recently-graduated high school students, may substitute other relevant current activities.

Judging: A committee comprised of representatives from the Washington State Auto Dealers Association and its affiliates will judge entries based on vision, originality, and quality of work and evaluate each using a point system as noted above. College Planning Network (www.collegeplan.org), a Seattle-based, non-profit organization assisting people seeking educational opportunities, is the scholarship program administrator.

Conditions of Award: Recipient must use their scholarship within the 12 months following the award. It may be used at any public or private school, vocational institution, community college or four-year college or university. Automotive Technology Program scholarships must be used at a Washington State public school Automotive Technology program (full list available at www.wsada.org). Awards not disbursed will revert back to WSADA.

Winning Entries: The winning entries may be reprinted or displayed, in whole or in part, in newsletters or other publications, cable or network television, and at www.wsada.org by the Washington State Auto Dealers Association. Scholarship recipients grant permission to the Washington State Auto Dealers Association to use his/her photograph, name, biographical information, and entry work as necessary in promotional or public relations materials related to the program. The organization will not share students' personal information with any third party entities.

Deadline: Submissions must be postmarked by April 16, 2018.

Did you remember to . . .

- Meet the 500 – 700 word limit for the essay
- Include two letters of recommendation (on letterhead) reflecting scholarship worthiness AND service to others
- Include a resumé of high school or relevant current achievements, etc.
- Include the completed Student Information/Release Form
- Ensure the entry is postmarked by the April 16, 2018 deadline
- Make a copy of your entry and Student Information / Release Form
